





## Commencement of RAS Admin Login Page Testing


## A. Login Screen



- 1. Remove the dummy content and use the original content.
- 2. The email validation is incorrect as there needs to be validation at client side (@ and .)
- 3. The error message needs to be shown above the login button / at the centre whenever wrong credentials are keyed.
- 4. When you click on the 'Forgot Password' link, there is no way to return to the login page
- 5. Clicking the Register link doesn't work.
- 6. Remember password Options are not working properly.




## B. Forgot Password Screen



- 1. The email validation is incorrect as there needs to be validation at client side (@ and .)
- 2. The error message needs to be shown above the login button / at the centre whenever an error from the user side occurs.
- 3. Remove the dummy content and use the original content.
- 4. Allow redirection from the 'Forgotten Password 'page to the Login page. Currently there is no way back to the Login Page.
- 5. Clicking the close button on the forgotten password page works fine. But when when the login button on the RAS website is clicked, the forgot password page comes back.




## C. OTP Verification Page


